1. Background and Context:

After the Bhopal gas tragedy in the year 1984, the environment of the city Bhopal had become highly polluted. Keeping in view the environment in Bhopal city, the utmost need of plantation was being felt. Illegal encroachment on government land was also seen. Keeping in view the above circumstances, Capital Project Forest Division, Bhopal was established by the Government of Madhya Pradesh by order number / 870/32/86 dated 21.02.1986 of Housing and Environment Department, under the capital project administration.

Paryavaran Vaniki Vanmandal, Bhopal. is working to fulfill the following objectives-

- 1. In Bhopal city, which is mostly hilly and stony, tree plantation should be done in a planned manner and the plants should be maintained till they are fully established.
- Based on requirement and demand of planting site, ornamental, shade providing, flower species and plants of environmental importance should be planted.
- 3. Beautification of the city by planting.
- Environmental upgradation through extensive and intensive planting as well as micro climate areas in Bhopal city.
- 5. Improving and upgrading the environment by planting suitable species around dirty drains.
- 6. Preventing soil erosion and improving landscape by soil conservation measures.
- Planting and maintaining suitable species on the land and sites owned by government, semi-government departments, institutions, and bodies from their or environment's planning and coordination organization's budget.
- 8. Regular protection, maintenance, and supervision of the planted areas, cutting and pruning in a forest-enhancing method
- 9. Pruning/sapping and eradication of unwanted vegetation.
- 10. To provide study place for post graduate and research level students of various colleges by collecting various plant species (including medicinal plants) in parks at one place.
- 11. Preparation of plants of various wild and local species by making nurseries for planting. Preparation of organic fertilizers to meet the requirement of local plantations.

- Proper management of small and big tree forests situated on the revenue land situated in the city and adjacent to it.
- 13. Plantation work in Bhoj wet land catchment area around Bada Talab.
- 14. Brief Summary of the projects undertaken under Paryavaran Vaniki Vanmandal Bhopal.

The current TOR is only for the part of the project being implemented in Bhopal, Madhya Pradesh. The project is being managed by the Principal Chief Conservator of Forests (PCCF), Research, Extension & Lokvaniki, in the State Forest Department. The project envisages to apply part of the grant proceeds for "Assessment and Valuation of Plantations done under Paryavaran Vaniki Vanmandal,Bhopal. (Former Capital Project Forestry Wing), Bhopal 1 in terms of Ecological & Project impact assessment, Biodiversity assessment, Carbon Stocks measurement and Ecosystem Services valuation". Though the area may be less but it is the lungs of the city of Bhopal

2. Objective of the Assignment:

In order to achieve the objectives of this assignment, Environmental Forestry (Capital Project Forest wing), Madhya Pradesh Forest Department, proposes to select an independent and external consulting firm/company with the requisite skills and proven experience in the field of Monitoring and Evaluation of Plantations, Biodiversity assessment, Carbon Stock measurement, Valuation of Ecosystem Services and Project Impact Assessment (EIA) (for the project- "Assessment and Valuation of Plantations done under Paryavaran Vaniki Vanmandal,Bhopal. (Former Capital Project Forestry Wing), Bhopal l in terms of Ecological & Socio-Cultural impact, Increase in Biodiversity and Ecosystem Services).

The aim of this assignment is to assess and document the increase/change in the green cover using secondary data and satellite imagery from year 1986 to 2023, assessment of carbon stocks and carbon sequestration from these plantations, valuation of Ecosystem Services in terms of Environmental, Socio-cultural and Economic benefits to the citizens of Bhopal city; because of the initiatives done under Capital Project by Environmental Forestry division.

Organization should have a minimum of 10 years experience in the implementation/research studies on policy issues, forests plantations monitoring, evaluation and assessment, NTFP/medicinal plants (development of protocols for sustainable harvesting processing and value addition, capacity building), Forest landscape restoration and climate change mitigation and adaptation Projects handles. The organization should have implemented at least 10 field projects during the period (10 years). Theses aspects will be evaluated based on publications and repots.

- Satellite image Analysis (pre and current) using google images for the project sites (1986 to 2023).

- Valuation of Ecosystem Services and identify Environmental, Socio-cultural and economic benefits to the citizens of Bhopal from the project.
- Measurement of Carbon Stocks and Carbon Sequestration from the plantation's sites.
- 5. Ecological Assessment and monitoring of Biodiversity of the plantation's sites.
